

ORDINANCE 2016-13 PARKING DECLARATION OF DESIGNATION

WHEREAS, on April 13, 2016, the Herriman City Council ("Council") met in regular meeting to consider among other things adopting an ordinance for a parking declaration of designations, and;

WHEREAS, on January 13, 2016, the Council adopted an ordinance adopting a parking permit program, and;

WHEREAS, the Community Development Director has determined that an area immediately surrounding Blackridge Reservoir ("Proposed Area") is adversely affected by commuter vehicles for extended periods during days, weekends and holidays, and;

WHEREAS, residents in the Proposed Area have consulted with the Community Development Director to tentatively establish the boundaries of an area proposed for designation, and;

WHEREAS, proponents of the parking permit area have submitted a petition in a form acceptable to the City containing the signatures at least fifty-one percent (51%) of the residents living in the boundaries of the area proposed for the parking permit area, and;

WHEREAS, the Council has determined that the petition contains the required signatures and the Community Development Director has recommended the establishment of a parking permit areas for the Proposed Area, and;

WHEREAS, on or before March 20, 2016, notice of a public hearing was published in The Salt Lake Tribune and Deseret News, posted not more than 400 feet apart along streets in the Proposed Area, mailed to property owners within the Proposed Area, and posed on the Utah Notice Website, and;

WHEREAS, on March 30, 2016, the Council held the requisite Public Hearing, and;

WHEREAS, after careful consideration, the Council has determined that it is in the best interest of the health, safety, and welfare of the citizens of the City to adopt a parking permit area and a parking declaration of designation.

NOW, THEREFORE, BE IT ORDAINED by the Council that it approves the designation of a parking permit area and that the following be adopted as a parking declaration of designation:

The program administration costs, the regular permit fee for two permits and one guest permit fee shall be \$25.00 per year. The cost to replace a lost or stolen regular permit or guest permit shall be \$5.00. Each permit shall be valid for one year and shall not be transferable. Each permit shall contain information to identify the purchaser's identity, claim for permit eligibility, authorized residential location, and the license number of the motor vehicle for which the application is made, and any other information that may be relevant.

The program participants shall display permits in the authorized vehicle at all times to be parked in the area for which the permit has been issued without being limited by parking regulations or prohibitions solely applicable to the commuter vehicles. Motor vehicles not bearing a permit properly that are located within the designated boundary shall be subject to parking citations in an amount not to exceed \$40.00.

The enforcement dates of the Parking Permit Area will be May 1^{st} – September 7^{th} . Enforcement hours are from 9:00 a.m. – 9:00 p.m.
